## Policies, release, waiver of liability and indemnification agreement (The "Agreement")

This agreement includes a release of liability and waiver of legal rights and deprives you of the right to sue the owner(s) of LifeWithParrots. Do not sign this agreement unless you have read and understand it in its entirety. Seek the advice of legal counsel if you are unsure of its effect.

In consideration for your bird being permitted to come to LifeWithParrots, you agree to all of the policies, procedures, release, terms and conditions set forth below.

#### 1. All birds must

- Be in general good health. Plucking/barbering due to stress, habit or hormones is acceptable
- Be completely weaned for at least 2 weeks
- Have no open wounds or major injuries occurring within thirty days prior to being dropped off
- Be harnessed or in a carrier when entering and exiting LifeWithParrots

## 2. Personal Property

LifeWithParrots will not be liable for any lost, stolen or damaged personal property belonging either to you or your bird. If your bird causes any personal property damage to the building, another bird or otherwise, you will be liable for the full cost of all treatment, repairs, and replacements.

#### 3. Fees

You must pay for all services by cash or e-transfer. Payment is due no later than upon completion of the appointment. If you fail to pay the full agreed amount by the completion of the appointment, you express permission for LifeWithParrots to keep your bird until the full agreed amount is paid. Overnight boarding fees will apply.

## 4. Aggressive Birds

Although LifeWithParrots loves for all birds to come for grooming, your bird may be asked not to return to LifeWithParrots if he/she exhibits aggressive or any other unacceptable behaviour. Such determinations will be made at the sole discretion of LifeWithParrots.

#### 5. WAIVER, RELEASE AND INDEMNIFICATION

YOU HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND LIFEWITHPARROTS, THEIR OWNERS AND VOLUNTEERS AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSES OR DEMANDS OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in anyway to any act or omission of the Releases. You agree that this release is binding on you and your successors, heirs, legal representatives and assigns. You also expressly and forever release LifeWithParrots from any duty to protect you or your bird from injury of any kind, and agree that any implementation of safety precautions by LifeWithParrots will not waive LifeWithParrots' right to be indemnified as provided here under, and such precautions will not alter this release. I INTEND FOR THIS AGREEMENT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY OF LIFEWITHPARROTS TO THE GREATEST EXTENT PERMITTED BY LAW; I AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THE REMAINDER OF THIS AGREEMENT WILL REMAIN IN FULLFORCE AND EFFECT.
