## **Policies, release, waiver of liability and indemnification agreement (The “Agreement”)**

This agreement includes a release of liability and waiver of legal rights and deprives you of the right to sue the owner(s) of LifeWithParrots. Do not sign this agreement unless you have read and understand it in its entirety. In consideration for your bird being permitted to come to LifeWithParrots, you agree to all of the policies, procedures, release, terms and conditions set forth below.

### 1. All birds must

- Be in general good health. Plucking/barbering due to stress, habit or hormones is acceptable
- Be completely weaned for at least 2 weeks
- Have no open wounds or major injuries occurring within thirty days prior to being dropped off
- Be harnessed or in a carrier when entering and exiting LifeWithParrots

### 2. Food

Birds will be fed in accordance with the instructions provided in the information form or instructions you later provide. You are responsible for providing enough food for your bird(s) stay unless an additional food budget is provided for LifeWithParrots to use.

### 3. Personal Property

LifeWithParrots will not be liable for any lost, stolen or damaged personal property belonging either to you or your bird. If your bird causes any personal property damage to the building, another bird or otherwise, you will be liable for the full cost of all treatment, repairs, and replacements.

### 4. Fees

You must pay for all services by cash or e-transfer. Payment is due no later than at the time you pick up your bird from LifeWithParrots. If you fail to pay the full agreed amount by the agreed pickup time, you express permission for LifeWithParrots to keep your bird until the full agreed amount is paid. Continuing overnight boarding fees will apply.

### 5. Aggressive Birds

Although LifeWithParrots loves for all birds to come for boarding, your bird may be separated from other birds or asked not to return to LifeWithParrots if he/she exhibits aggressive or any other unacceptable behaviour. Such determinations will be made at the sole discretion of LifeWithParrots.

### 6. Abandoned Birds

If your bird is left at LifeWithParrots without any contact, instruction or notification regarding its pickup from you or your authorized persons after one hundred and sixty-eight (168) hours past the scheduled pick up date, your bird will be deemed “Abandoned”. If you abandon your bird at LifeWithParrots, LifeWithParrots will become its legal owner and guardian. LifeWithParrots will, in its sole discretion, determine whether to keep, re-home or relinquish the bird to an approved home of LifeWithParrots' choice. **YOU FULLY UNDERSTAND AND AGREE THAT IF YOU ABANDON YOUR BIRD AT LIFEWITHPARROTS, YOU MAY BE UNABLE TO RETRIEVE POSSESSION OF YOUR BIRD AND WILL HAVE NO RECOURSE AGAINST LIFEWITHPARROTS.**

## 7. Duty to Disclose

You must disclose on a continuing basis, any and all medical or other conditions, including but not limited to personality concerns or behavioural incidents that in LifeWithParrots' sole discretion, may affect, limit or prevent your bird's ability to participate in any boarding activities.

## 8. Veterinarian Liability and Care

LifeWithParrots will have the right to obtain medical treatment for your bird, if, in LifeWithParrots' sole discretion, it appears that your bird may be ill, injured or exhibits any other behaviour that would reasonably suggest that your bird may need medical treatment. Reasonable efforts will be made to contact you when LifeWithParrots determines that medical treatment is necessary, but if LifeWithParrots is unable to contact you or your emergency contact, LifeWithParrots and the veterinarian may rely on this Section 8 as your consent to treat your bird. You hereby grant the veterinarian and LifeWithParrots the right to make medically necessary decisions for your bird's treatment, and release the veterinarian and LifeWithParrots from all liability for the same. If you are unable to be reached but your emergency contact is reached, you hereby grant your emergency contact the right to make medically necessary decisions for your bird's treatment. LifeWithParrots will first attempt to seek treatment from the veterinarian provided in the Information Form ("Designated Veterinarian"), but will have the right to seek veterinary treatment from an alternative veterinarian if: (i) the bird needs urgent care and another veterinarian is closer, (ii) LifeWithParrots is unable to reach the Designated Veterinarian, or (iii) LifeWithParrots is unable to transport the bird to Designated Veterinarian. You will be fully responsible for ALL costs related to any medical treatment, including without limitation, the cost of any transportation for the purpose of such treatment. You must also provide veterinary records to LifeWithParrots upon request, and you hereby grant LifeWithParrots permission to request and obtain veterinary records directly from your Designated Veterinarian, if LifeWithParrots is unable to obtain necessary records from you.

## 9. WAIVER, RELEASE AND INDEMNIFICATION

YOU HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND LIFEWITHPARROTS, THEIR OWNERS AND VOLUNTEERS AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSES OR DEMANDS OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in anyway to (i) any act or omission of the Releases, (ii) your bird's participation at any overnight boarding. You agree that this release is binding on you and your successors, heirs, legal representatives and assigns. You also expressly and forever release LifeWithParrots from any duty to protect you or your bird from injury of any kind, and agree that any implementation of safety precautions by LifeWithParrots will not waive LifeWithParrots' right to be indemnified as provided here under, and such precautions will not alter this release. I INTEND FOR THIS AGREEMENT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY OF LIFEWITHPARROTS TO THE GREATEST EXTENT PERMITTED BY LAW; I AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THE REMAINDER OF THIS AGREEMENT WILL REMAIN IN FULLFORCE AND EFFECT.

I, the undersigned, hereby acknowledge and agree that all the information provided in this information form is complete and accurate to the best of my knowledge. I consent to LifeWithParrots' use of such information for all lawful business purposes which may include, but is not limited to, for example, providing LifeWithParrots services to you and using data that includes information about you and your bird for marketing or other purposes. I further acknowledge and agree that I have read, understand and agree to all the terms and conditions contained in the Boarder Release, Waiver of Liability and Indemnification Agreement, as they may be amended from time to time, which are attached and fully incorporated into this application by reference. I hereby execute this information form and the Agreement for my bird, myself and my heirs, successors, representatives and assigns. I further attest that if I am not the owner or sole owner of the bird for whom this information form has been completed, my signature is sufficient to enter into this Agreement for and on behalf of any other owner or representative. I hereby agree that a true and correct copy of this document may be produced in lieu of the original application. Should a copy be produced, I understand that it is legally enforceable and does not affect the terms of the application in any way.
